

Note: Why I Am Uploading These Files (Safeguard Position Against Barnes & Partners & Co!

I am uploading Nan's will, the probate grant extracted by Barnes & Partners, and the valuation documents for 280 Durants Road **to protect my position**. These documents are included **only because of the actions Barnes & Partners have taken against me**, and because they have **never declared who they are to me**, nor the basis on which they are interfering with my mother's estate.

This note explains **why I am allowed to upload these files**, and **why it is necessary**.

1. Barnes & Partners never declared their status or authority to me

Barnes & Partners:

- Never told me who they were in relation to my mother's estate
- Never declared any conflict of interest
- Never explained their involvement
- Never provided a lawful reason for blocking me
- Never acknowledged their prior role in Nan's estate

This is a serious omission, especially because I am the **eldest child**, and the normal legal position is that I would administer my mother's estate unless there is a valid objection.

They did not provide one.

2. They filed a caveat first — without giving any reason

Instead of declaring:

- Why they were stopping me
- What their legal standing was
- What their objection was
- Who they were acting for

they immediately filed a **caveat** to block me.

This was done **without explanation, without notice, and without any lawful justification provided to me**.

3. **When that fails, try to force me to sell my home**

This is why I must upload the documents showing their prior control of Nan's estate.

5. Their prior control of Nan's estate is directly relevant

Barnes & Partners:

- Extracted Nan's probate
- Administered Nan's estate alone
- Set the estate valuation
- Controlled all decisions
- Never involved the family
- Never declared their role afterwards

Their past authority connects directly to their current actions.

This is why uploading the documents is necessary:

- To show their prior involvement
- To show their pattern of behaviour
- To show their failure to declare themselves
- To show their conflict of interest
- To show why their actions now cannot be separated from their actions then

This is not about challenging Nan's estate. It is about **protecting myself** from a solicitor who has acted against me twice without explanation.

I am uploading these files because:

- Barnes & Partners acted against me without declaring their authority
