I JAMES EDWIN CORDELL of 280 Durants Road Ponders End Enfield Middlesex EN3 7AZ HEREBY REVOKE all former Wills and testamentary dispositions made by me and I DECLARE this to be my last Will

- 1 If my wife CATHERINE CORDELL should survive me for a period of thirty days then subject to the payment of debts duties funeral and executorship expenses I GIVE to my said wife all my estate whatsoever and wheresoever absolutely and I APPOINT her to be the sole Executor of this my Will
- 2 If my wife should not so survive me or this gift should otherwise fail then but not otherwise the following provisions of this Will shall have effect
- 3 I APPOINT my daughter SHEILA ANNE LEWIS of 23 Brook Crescent Edmonton London N9 and my daughter LORRAINE CAROLYNE CORDELL of 23 Byron Terrace Edmonton London N9 to be the Executors and Trustees of this my Will
- 4 In this Will the expression "my Trustees" shall mean my Executors and the Trustees of this Will and of any trust arising under it
- 5 I GIVE all my real and personal estate whatsoever and wheresoever to my Trustees to hold the same on trust to retain or sell it and:
 - 5.1 To pay debts and executorship expenses including funeral expenses
 - 5.2 To pay any inheritance tax or other taxes or duties due in respect of property passing under this Will or as a result of my death and if applicable in respect of any transfer made by me in my lifetime
 - 5.3 To divide the residue equally among those of my children

SHEILA ANNE LEWIS and LORRAINE CAROLYNE CORDELL and ANDREW JAMES EDWIN CORDELL who survive me but if any of these should die within thirty days of my death or predecease me leaving surviving children then such children shall take (in equal shares if more than one) that share which their parent would otherwise have taken

6 In the absence of proof of dishonesty or the wilful commission of any act known to be a breach of trust none of my Trustees shall be liable for any loss

7 I WISH my body to be cremated
