In line with our new criteria for rehousing, your case was presented to our Priority Needs Panel and I am pleased to inform that it has been agreed that you will be given one direct offer of suitable accommodation.

What are the next steps?

1. You have been placed on our Rehousing List for urgent rehousing.
2. The property offered will have the same number of bedrooms as your current home. Our Rehousing Service is not able to resolve issues of overcrowding and the priority is to move you to an area of safety.
3. You will be rehoused outside of the risk areas as identified by your Neighbourhood Housing Lead and/or ASB Case Worker.
4. You will only be made one offer of accommodation. If you choose not to accept the offer made, you will have the option to appeal by submitting in writing the reasons for the refusal within 5 days. The property will be held pending the outcome of the appeal which will be represented to an independent panel for consideration.
5. You will be expected to sign a new tenancy. As part of this process, you will be required to

Leaving a vulnerable person in priority need homeless on the street.

There is proof she self-harms so why is it saying there is no evidence?

Enfield Council knew about Deon before the attack on 25/11/2023, Deon was attacked at her flat, in 2017 by 3 males which should be well documented at Enfield Council as she was given points to bid. Enfield Council is also aware of all the issues Deon had with her neighbor down stairs and give her more points to bid, due to what it was doing to her mental health.

How Enfield Council is saying the attack on Deon was not premeditated on the 25/11/2023 is beyond me, the people left the pub, then came back to the pub and this is when the attack happened.

It seems that the medical records Enfield Council are using are incorrect. Deon got attacked on the 26/11/2023, the hospital could not stop the bleeding, North Middlesex could not deal with the injury and had to send her to the royal free, the royal free never had any beds, so she stayed at north Middlesex until they were able to stem the bleeding, give her blood transfusions send her home to go to the royal free in the morning, she went but there was no doctor to do the operation needed to the hand, so she went back on the 27/11/2023 were the operation was carried out.

Why did Enfield Council not tell Deon about the rough sleeping team as if she had known she could have got some help? Deon has been walking the streets at night and sleeping in the day.

Deon has always had mental health issues since she was a child, it seems records are missing I have requested an SAR from all the mental health services but as of yet have not got anything back. Deon mental health has got a lot worse in fact and that is what the documents have said.

Dr Ash Thakore seems to have done a paper base review how is any doctor meant to get the full picture of someone mental health with a paper base review yet not see the person. So its only a paper base review?

I believe section 27 / J is what deon comes under.

It is now also stated Deon had PTSD which she is waiting for treatment along with other treatment for her mental health.

Enfield Council seem to think Deon is doing everything herself as that is what has been stated by them, yet it has been her family that has got her a solicitor and heling her to write things up and make calls, there is nothing about Deon's dyslexia learning difficulty. Deon has never been able to deal with things herself since she was a young child and has always needed a great deal of help. And it has been her family that are the ones that help her.
