I am writing to you as I will be assisting with the appeal.

As you know, we are very tight with deadline. We have asked for the statements by no later than 10:30 today. I have just been passed on bank statements for Natwest and Barclays account. The Barclays statements are

only from Jan-Feb which will not be accepted by legal aid agency. We would need it to cover until 28 April 2023.

I also note that on the Natwest account there are various transfers to another account ending with 8161. The legal aid agency would want 3 months statement for this account too covering 28 Jan - 28 April 2023. The deadline to lodge appeal would be by hand on 4 May 2023. It will be very difficult to find counsel on short notice to give opinion if I do not instruct one today.

I would need the missing documents by no later than 2PM today otherwise we may not be able to assist.

I will enquire with counsel now to see if they have capacity to assist on a short notice but please send the complete statements by no later than 2PM today as it is bank holiday on Monday.
