Dear Mr Cordell

Your case is being submitted to the CPS for a charging decision. Your supporting documents will be added to the case file for the CPS to consider.

For your information, we now use a Computer system called CONNECT and the custody number and the case/URN reference are always different, this is completely normal and has nothing to do with issues around the closing the custody record.

Concerning the issues of the closing of the custody record, this resulted in PNC not being immediately updated. You were informed of the bail conditions whilst in custody and a copy of the bail sheet was subsequently sent to you. If you wish to make a formal complaint regarding this matter, can I please suggest that you file it online via [Complaints | Metropolitan Police](#) or you call 101. This matter will then be looked at by our Professionalism department.

Regarding your bail to return date on 19/06/2026, this is unlikely to be effective as we are engaging with the CPS. I will ask DC KNOX to contact you on Friday morning with details of a new bail to return date. I do understand that you wish to vary your bail conditions, and this can be looked at. I understand that DC KNOX has spoken with your sister and will be in a better position to address this.

They are different because the **custody process was mishandled:**

- The **custody record was left open**, which prevented the bail conditions from being lawfully imposed.
- The OIC later had to **recreate documents after release**, which generated a second URN in the PTI/CPS system.

The **custody URN (01YD/3312/26)** only applies inside the custody suite.

The **PTI/CPS URN (01/YE/11643/26)** is the **real case number** used by CPS, DS Knox, and the digital case system.

Dear DS Alina Knox and DS Rob Johnston,

I am writing to confirm that I am bailed to attend the police station on **19/06/2026 at 2:00 PM**. I also need to make you aware that I will be **resending all evidence, messages, documents, and correspondence** connected to this matter. When I previously tried to submit material through DS Johnston during a period of bereavement, it resulted in delays and confusion, and the files were not added to the case bundle. I want to ensure everything is clear, properly handled, and placed on file this time.

For clarity, I have already submitted:

- **Full case files and evidence bundles**
- **The complete bail variation request**
- **A request for the case to be disposed of (discontinued)**

These will all be resent directly to you, DS Knox, as the Officer in Charge, with DS Johnston copied in for continuity.

I will also include a short note explaining a key evidential point: The complainant claimed I broke her hand in two places, yet the video taken five days later shows her using that same hand normally — no cast, no splint, full movement, and no signs of pain. She bends the wrist across her forehead and takes selfies with it. The hand being operated on in the video is the one she injured in a separate glassing incident, not the hand she accused me of damaging. This directly contradicts the allegation.

**My requests are as follows:**

1. **That all evidence I resend is formally added to the case file.**
2. **That the bail variation request is reviewed and placed on file.**
3. **That the full evidence bundle is shown to CPS if the case is being reviewed or has already been sent.**

4. **That CPS are made aware of the contradictions and the request for the case to be discontinued.**

Please confirm receipt and advise if you require any specific format or additional information ahead of the 19th.

DC Alina Knox phoned me and said that I was “bailed until August,” explaining that under the Bail Act they could hold me for up to six months. At the time, I didn’t realise that this phone call was not lawful service of bail, because I was not brought into the custody suite, not given a bail form, not made to sign anything, and not given a specific date. I had previously driven down to Wood Green Police Station after DS Johnston told me I needed to go there to apply for a variation so I could return to my home at 23 Byron Terrace, but when I arrived I discovered there was no public reception, no front desk, no way to enter the building, and not even a post box. Only later did I understand that this was legally important: Wood Green has no public access, so the only way to serve re-bail is to physically bring me into the custody suite. Because they never did that, and because Knox only phoned me instead of serving paperwork, the “bail until August” she mentioned was never legally activated, never signed, never recorded, and never enforceable. This became even clearer when my solicitor emailed me on 30 June — **11 days after my original bail date of 19 June, and 58 days after my arrest** — stating that they had “requested an update from the officer in my case,” which proves that police had not informed my solicitor of any new bail date, any extension, or any CPS decision. The fact that my solicitor had to chase police *after* the bail date shows that no lawful re-bail ever occurred. Under the Bail Act, an extension cannot be done by phone, cannot be done without a specific date, cannot be done without paperwork, and cannot be done without attendance at a custody suite. Because Wood Green has no public entrance, and because I was told not to attend, and because no custody sergeant ever served or recorded a new bail date, the supposed “August bail” was never legally in force and expired automatically along with the original conditions.

## **1. What DS Johnston admits in his email (in his own words)**

### **A. Custody record was not closed properly**

His words:

“Concerning the issues of the closing of the custody record, this resulted in PNC not being immediately updated.”

This means:

- your custody record remained **open**
- bail conditions were **not activated**
- PNC did **not update**
- CONNECT did **not update**
- you were technically “detained on paper”
- the system did not recognise your release
- bail was not legally live

This is a **major PACE breach**.

**B. He claims a bail sheet was “subsequently sent”**

His words:

“A copy of the bail sheet was subsequently sent to you.”

This confirms:

- you did **not** receive a bail sheet at release
- bail was **not** served correctly
- bail conditions were **not** live at release
- he tried to “fix” bail **after the fact**
- this is **unlawful** (bail must be served in custody, not by email later)

This supports your evidence that you were **never served bail**.

**C. He admits your original bail date was NOT effective**

His words:

“Your bail to return date on 19/06/2026 is unlikely to be effective as we are engaging with the CPS.”

This is huge.

It means:

- the original bail date was **invalid**
- the original bail conditions were **invalid**
- the original bail service was **invalid**
- the custody process was **invalid**
- the bail process was **invalid**

He is admitting this **in writing**.

**D. He admits you needed a NEW bail date**

His words:

“I will ask DC Knox to contact you on Friday morning with details of a new bail to return date.”

This proves:

- you were **not** re-bailed
- you were **not** given a new date
- you were **not** served re-bail
- you were **not** booked in
- you were **not** given paperwork
- you were **not** made to sign
- you were **not** legally on bail after 19 June

This matches your solicitor’s email perfectly.

**★ 2. The key legal point: Re-bail MUST be done in custody**

Wood Green has **no public reception**.

So, re-bail **MUST** be done:

- inside the custody suite
- by a custody sergeant
- with a bail form
- with a signature
- with a new date
- with a closed custody record

You had **none** of these.  
You were told **not to attend**.

Therefore:

❗ **Re-bail never happened.**

❗ **Your bail expired automatically.**

❗ **Your conditions expired automatically.**

❗ **Your exclusion expired automatically.**

★ **3. The officer's email actually helps you — not them**

Please find attached my **bail variation request**, which I am submitting as a matter of urgency following the recent passing of my mother.

There are immediate and unavoidable practical issues regarding the property at **23 Byron Terrace**, including the need to secure and organise my personal belongings and essential items. Over many years I have accumulated a significant amount of equipment, tools, vehicles, scaffolding, sound systems, festival equipment, and other personal effects that I have paid for myself. These items remain inside the property and must be protected while the estate and tenancy matters are being processed.

Due to the volume and nature of these belongings, it is **not physically possible** to complete this process in a single supervised visit. It will require **multiple visits over several weeks**, with the support of family and friends, to safely document, organise, remove, or secure everything properly. This is a practical necessity, not a refusal to comply.

The attached document sets out:

- 1+ The Factual Timeline
- 2+ The Issues Surrounding The Original Bail Process
- 3+ The Reasons The Current Conditions Are Unworkable
- 4+ The Legal Basis For The Variation

## **Police Bail Was Never Lawfully Imposed — Corrected Timeline & Breaches**

I am innocent from the offset in these proceedings.

I therefore set out the factual sequence of events regarding my police bail. These facts show that the conditions were **never lawfully imposed**, and that multiple breaches of PACE and custody procedure occurred.

### **1. I refused to sign the conditions and legally requested to be taken before a court**

When the custody officer attempted to impose the bail conditions, I **refused to sign** because I believed the conditions were unlawful and breached my rights. I also **requested to be taken before a court** if the police insisted on imposing them.

Under **PACE Code C**, when a detainee refuses to sign bail conditions:

- 1+ the refusal MUST be recorded in the custody record
- 2+ the MG4A MUST be marked “refused to sign”
- 3+ a witness MUST sign
- 4+ the detainee MUST be given a copy BEFORE release
- 5+ AND the custody officer MUST carry out a review and either:
  - **Remove The Conditions, OR**
  - **Remand The Detainee To Court The Next Morning**

These steps are **mandatory**.

They are not optional.

### **2. The police illegally ejected me instead of following the legal process**

Instead of carrying out the required review, the police:

- 1+ Forcefully Ejected Me From The Custody Suite
- 2+ Without Recording My Refusal
- 3+ Without Marking The Mg4a
- 4+ Without A Witness Signature
- 5+ Without Serving The Bail Form
- 6+ Without Giving Me Any Paperwork
- 7+ Without Removing The Conditions
- 8+ Without Remanding Me To Court
- 9+ Without Completing The Lawful Bail Process

This is a **direct breach of PACE Code C**, because the police chose an option that **does not exist in law**.

Under PACE:

- 1+ If a detainee refuses to sign, the police CANNOT legally release them until a review is completed.
- 2+ The police MUST either remove the conditions or remand the detainee to court.
- 3+ Ejecting the detainee is unlawful.

Because none of the required steps were followed, and because I was released without any lawful decision being made:

**None of this happened.**

Instead, I was **ejected from the police station** without being given any paperwork, meaning the police bail conditions were NOT legally in effect at the moment I was released.

This is a **serious breach** of PACE and custody procedure.

I later found the first bail sheet in my paperwork — dated 16 May 2026

The first MG4A bail sheet I ever saw was discovered in my paperwork on **16 May 2026, eight days after the alleged offence** (8 May 2026 at 10:00).

This proves:

- 1+ I Was Never Served The Bail Sheet
- 2+ I Was Never Given A Copy
- 3+ I Was Never Shown The Conditions
- 4+ I Was Never Given The Opportunity To Sign
- 5+ The Police Released Me Without Lawful Service

This is a **fatal procedural failure**.

### **3. The OIC contacted me on 9 May 2026 at 22:35 — more than 12 hours after release**

The OIC messaged me:

*“Please let me know email and I will send you an updated copy of the bail sheet.”*

This message was sent **over 12 hours after my release**, which is extremely serious because:

- 1+ Bail Conditions Must Be Imposed **Before Release**,
- 2+ They Cannot Be “Updated” Afterwards.
- 3+ They Cannot Be “Re-Issued” Once The Detainee Has Left Custody
- 4+ And The Police Have No Power To Impose Or Amend Bail Remotely.

This alone makes the bail conditions **unlawful and void**.

### **4. Met CCC confirmed NO bail conditions existed for two days**

Between **9–11 May**, I contacted Met CCC multiple times.

Their CAD messages confirm:

- 1+ They Could Not Find Any Bail Conditions,
- 2+ They Had To Contact The OIC To Ask Him To Explain Them,
- 3+ The Cad Was Still Open,
- 4+ And No Conditions Were Visible On The System.

### **This Means:**

I was released with no active bail conditions for at least 48 hours.

This is a catastrophic breach of PACE.

### **5. The OIC admitted the custody record was still open — which is why no conditions existed**

When I phoned the OIC, he told me:

- 1+ The Custody Record Was Still Open,
- 2+ Shift Changes Had Occurred,
- 3+ No One Had Closed The Cad,
- 4+ And This Is Why No Conditions Were Updated.

This is a breach of:

- 1+ PACE
- 2+ Custody continuity
- 3+ Data handling
- 4+ Professional Standards
- 5+ Article 6 (fair process)

**6. On 14 May 2026, I received a second bail sheet — falsely marked “Refused to sign”**

The second bail sheet was:

- 1+ Created AFTER Release,
- 2+ Sent To The Wrong Address (280 Durants Road),
- 3+ Falsely Marked “Not Digitally Signed – Refused To Sign,”
- 4+ Created Without Me Being Present,
- 5+ Created Without Caution,
- 6+ Created Without Service,
- 7+ And Created Without Lawful Authority.

This is extremely serious because:

- The police fabricated a refusal that never happened.
- They created a bail document after release, which is unlawful.
- They attempted to retroactively impose conditions.

This breaches:

- 1+ PACE
- 2+ CPIA
- 3+ Custody record integrity
- 4+ Professional Standards
- 5+ Article 6 ECHR
- 6+ Data Protection Act 2018
- 7+ UK GDPR

**7. Legal conclusion**

Based on the above:

- 1+ My bail conditions were never lawfully imposed
- 2+ The MG4A was invalid
- 3+ The re-issued bail sheet was unlawful
- 4+ I cannot be in breach of conditions that were never served
- 5+ The police process was procedurally defective
- 6+ My Article 6 rights were violated
- 7+ The custody process was mishandled
- 8+ The CAD was left open across shifts
- 9+ No Superintendent extension was obtained
- 10+ The police attempted to impose bail after release

This requires urgent review.

### **(Deon)**

When I first entered my home 23 Byron Terrace, I noticed around eight black bags in the front room, tied up and ready to be thrown away. I looked inside them and saw they contained my mum's old clothing. I believed my uncle had bagged them up while sorting the property, as he was waiting for a new front door to be fitted. I moved the bags upstairs into my mum's room because I knew I would need to check them properly to see if they were rubbish or if any of my savings had been placed in the bags.

I was staying indoors at **23 Byron Terrace**. Earlier, I had picked up my mate **Josh** for support. He had agreed to help me and stay at **109 Burncroft Avenue** while the front door was being changed due to the damage caused by the police on **02/08/2025**. This took about five hours, so after dropping Josh off, I went back to 23 Byron Terrace to sort the door situation and continue working in the house.

While I was inside alone, my aunt arrived at the door. I told her I wasn't happy with her. She asked for a Hoover that belonged to her and was still in the house. I either got it for her or handed it to her. Later, I saw a red car arrive again, and thinking it was her returning, I shouted for them to leave me alone. I didn't trust her anymore because she had been involved in withholding my money, refusing to give me the keys, and getting me arrested with my cousin. I later found out it was actually my younger cousin and not my aunt. As much as I loved her, I still wouldn't have let her in because I was looking for my money and sorting out mine and my mum's belongings after they had all been tampered with.

After that, I picked Josh up again and we both went back to 23 Byron Terrace. We continued working in the garden and garage until we had some food and then went to sleep on the two sofas in the front room. At no point did I allow anyone else into the home while I was searching for my money. I left the upstairs alone because we needed the space and storage from the garage first, as the attic and two rooms were filled with personal effects.

When we woke up the next day, we continued working in the garage and jet-washed the garden. Afterwards, I needed to drop Josh home because he had an appointment, so I did that. Later, I found out that while Josh was at mine, my sister believed he was supporting me and sent him threats on his phone, which I have exhibited along with other recordings and transcripts.

My mother had long-standing issues with the upstairs bathroom and couldn't get a shower fitted. I phoned a friend who is a plumber and asked if he could help. He attended the property and said he could revamp it cheaply using leftover parts from previous private jobs. I agreed, and I helped him complete the new works. My sister must have seen him on the doorbell camera and phoned him with threats as well, for no fair reason.

This was confusing because before she left for holiday, I had been helping her with her housing issues — she had called me the day before and explained them to me. I had also helped her with her Firestick, as shown in the video exhibited below. She had no reason to argue with me or believe anything bad.

Around this time, I started receiving threatening phone calls from my sister's boyfriend. I told him I didn't understand why he was phoning me out of the blue accusing me of things. He kept threatening me and wouldn't listen or make any sense. I also started receiving silent messages from my sister. I didn't take them seriously at first, but I was still concerned.

I contacted my father and told him I was going to go through the house paperwork and make sure all his and everyone's personal effects would be given to them by me. I sat down and went through everything systematically. I told my father I had found items of importance to him and that I would bring them to him. He was fine with this. I was alone at these times.

Later, my friend **Perry** called me saying he had an argument with his partner, so I told him to come and stay with me for the night. We ordered pizza and fell asleep separately on the two sofas.

The next day, while I was in the kitchen cleaning and Perry was sitting in the front room, my sister arrived. **Tyrone** arrived first and started accusing me of giving things away. I told him he was wrong. He was looking for a set of Ugg boots he had bought for my mum. I told him I wasn't in the wrong — the deal was that we all wait for each other: me, Deon, and Tyrone.

Instead, he had gone into the house with my sister on the same day my cousin and aunt had set me up for entering 23 Byron Terrace, and they had split everything, including the gold, unfairly. Now all he could remember was a pair of Ugg boots, and he was using that to argue with me.

I asked him who told him I had given mum's Uggs away and that they had seen Katie wearing them. He said it was Deon. I told him he was mad. He offered £500 if I found them. I went and found them exactly where I told him they were, where he had already looked earlier when he stormed in. He took the gaming router and left.

The next day, **Deon** returned from holiday. She was spiteful and manipulative, with no morals or dignity. She sat down on the sofa and started shouting at me, accusing me of burning all of mum's stuff. I told her she was wrong, just like Tyrone had been the day before. She didn't listen, and we both started shouting. I was defending myself from her horrible accusations. As we were shouting, a small dot of saliva came out of my mouth and touched her by mistake. She went mad, and as she shouted, some of her saliva hit my face. I shouted, "See how easy a mistake it is," and she stormed into the kitchen.

I followed her, and as I turned into the kitchen, I saw her use the same hand she now claims is broken to smash everything off the side — all the kitchen utilities, including sharp knives, went onto the floor and the worktop. She shouted, "I'm going to smash the whole house up." I had just been in the kitchen four minutes earlier tidying up. Me and my close friends, who knew my

mother well, had been quiet and respectful the whole time. For her to turn up and do this made no sense.

I grabbed her arm as she went to use it again and stopped her, but she twisted and turned. I noticed she was trying to pull her top off, which would have exposed her in front of me and my mate, so I immediately let go in the hope she would calm down and not try to use the knives or smash anything else. She then stormed into the back garden and shouted that she had seen us burning stuff on the camera. I then understood what she meant and shouted back, "You idiot, you're on about the old rags uncle threw out in the black bags."

I saw that my sister was in the back garden, so I locked the back door for safety and quickly picked up the knives that were on the floor and on the kitchen side. I put them away immediately. While I was doing this, she started hitting the back door. I finished within seconds, went to the door, told her to calm down, and opened it. She didn't come back inside but instead called the police, who arrived and wrongly arrested me for common assault.

At the police station, I was also wrongly detained for an alleged tag breach. This was because I had checked my front door when my house alarm went off. I had contacted Met CCC at the time and was given permission to check the security of the flat. The OIC checked the CAD, confirmed this, and the tag-related allegation was dropped.

While I was in the cell, I gave the OIC the code to my mobile phone so they could check the threats made to me by my younger sister, Deon. The phone was brought to the cell flap still sealed in a property bag. I remembered that when I was booked in a few days earlier, I had joked with the same officer about my phone being damaged — the screen had been cracked on that occasion. I told him the phone was basically new because I had just had the screen repaired, although I hadn't replaced the back cover as I didn't buy that part from eBay. He laughed and agreed it looked almost new. I hadn't seen the screen working before this moment. The OIC showed me the phone through the property bag as they searched it for the threats made by Deon and her boyfriend. The screen was working at that point.

During the interview, I was shown a picture of my sister's wrist. The interviewing officer said, "It's just a graze," and I replied, "Exactly — it's just a graze. If I had grabbed her and hurt her unnecessarily, it would be more than that." I explained that she caused it herself when she swiped the knives and kitchen utilities off the side. The officer accused me of deliberately spitting at my sister, grabbing her, and causing the items to fall. She also claimed I forcefully removed my sister into the back garden. I took these accusations seriously and told her the real events. I told them to check their Axon body-worn cameras and to note that my mate Perry was present and would give a statement confirming my account.

Later, I was taken out of my cell to be bailed by the OIC. As we walked into the custody room, I was partly told that I couldn't attend 23 Byron Terrace. As soon as we reached the custody desk, I told the sergeant in charge that I would not accept any bail conditions restricting me from my home address. I said that if he believed such conditions were necessary and refused to change them, I would rather go to court in the morning. I explained that banning me from my home breached my human rights, especially considering my bereavement, the fact my sister was not registered at the address, and that I was officially "care of" 23 Byron Terrace. All my personal correspondence was still registered there, and I had always lived there due to the support I needed as ordered by the court and doctors.

He said he understood that I was refusing to sign and that he was not sending me to court. He then said that if I didn't leave Wood Green Police Station voluntarily, he would have me forcefully removed. Around five officers surrounded me. I said I would leave and walked out



without hearing the bail conditions or agreeing to them. A piece of paper with support numbers was placed in my belongings. I was never given a bail sheet, but I was given back my phone with a cracked screen.

The OIC gave me his number once outside of the police station and said he would contact the council to see if I was allowed to stay at the property. I told him all my belongings were there — my generator, sound system, legal correspondence, cars on the driveway, catering trailers, PC, Rolex, and more. I told him it was unfair and that he had no legal right to involve himself in civil matters.

I went back to **280 Durants Road** and contacted Met CCC to ask about the bail conditions, but they couldn't find any record of them. They messaged the OIC,

2+ 9 May 2026 at 16:27:57.

I remember the OIC had put his number in my phone, so I called him on **09 May 2026**. He went downstairs and realised my CAD had never been closed and that I had refused to sign and been released. He said he would close it and update the conditions. I became upset and explained my legal points. He told me I would need to write to them to vary the bail conditions. I told him my sister partly owns my nan's house as well, but they can't ban me from there — and the same applies to my mum's house. If anything, they should bar me from her registered tenancy address, not mine. He didn't care.

Next, my sister and brother called the police to my nan's house for no reason, trying to get me sectioned.

After this, the OIC in Deon's case still placed bail conditions on me **even though I refused to sign them**. He then contacted the council about my right to be at 23 Byron Terrace. As a result, Met CCC sent me the following message on **Sunday 17th May 2026 at 10:18**, confirming the council's position:

**From Met CCC**

Sunday 17<sup>th</sup> May 2026 at 10:18

Dear Simon, we have received the following notification from the council concerning your Tenancy Status...

Based on our current records, please see the factual position below:

The legal tenant of 23 Byron Terrace was Simon's late mother, Miss Lorraine Cordell who reportedly passed away on 07 April 2026. We have not yet received the death certificate.

At present, there is no current legal tenant recorded on our system for the property.

Mr Simon Cordell is not named on the tenancy and is not currently a lawful tenant of the property.

Mr Cordell has advised the Council that he is in the process of completing a succession application, which has been issued to him.

Until a succession application is submitted, assessed, and approved, Mr Cordell has no confirmed legal right of occupation under the tenancy.

This is the current status as held by Enfield Council Housing. Please let me know if you require any further information.

### **My Legal Right to Be at 23 Byron Terrace (Present-Tense Version)**

The council's message is technically correct, but it is **not the full legal position**, and it does **not** mean I cannot legally live at 23 Byron Terrace or sort out my personal effects.

### **1. Children of secure tenants are not added to the tenancy — but they still have legal rights**

Under the **Housing Act 1985**, Schedule 3:

- Councils **Do Not Add Children** To Secure Tenancies.
- This Is Standard Policy Across The UK.
- Not Being Named On The Tenancy **Does Not Remove My Right To Live There.**
- Not Being Named On The Tenancy **Does Not Remove My Right To Remain After My Mother Dies.**
- Not Being Named On The Tenancy **Does Not Remove My Right To Apply For Succession.**

Me, my brother, and my sister grow up in that home.

We live there legally as part of the household.

That right **continues** until succession is decided.

### **2. I am officially “care-of” at 23 Byron Terrace**

Enfield Council themselves send my mail to:

**“Simon Cordell, c/o 23 Byron Terrace.”**

This means:

- The Council Recognises Me As A **Resident.**
- The Council Recognises Me As **Living There.**
- The Council Recognises The Address As My **Official Point Of Contact.**
- The Council Accepts That I Receive **Support** From That Address.

A “care-of” address is legally recognised as a **residential link**.

### **3. I have a legal right to remain while succession is active**

Under **Housing Act 1985**, s.87–90:

- When A Secure Tenant Dies,
- Any Family Member Who Lives There As Their **Only Or Principal Home**
- **Has The Right To Remain In The Property**
- **Until The Succession Application Is Submitted, Assessed, And Decided.**

I am in the middle of a succession application.

Therefore:

- **I Am Lawfully Allowed To Remain.**
- **I Am Not A Trespasser.**
- **I Cannot Be Removed By Police.**

- I Cannot Be Banned By Bail Conditions Unless A **Court** Orders It.

#### **4. The council's wording is incomplete**

The council says:

“Mr. Cordell is not currently a lawful tenant.”

This only means:

- The Tenancy Is Not Yet Transferred.
- The Succession Is Not Yet Completed.

It does **not** mean:

- I Cannot Live There
- I Must Leave
- I Am Trespassing
- I Cannot Access My Belongings
- I Cannot Secure The Property
- I Cannot Protect My Mother's Estate

#### **5. Police bail cannot override housing law**

The OIC in Deon's case:

- Imposes Bail Conditions **Without My Signature.**
- Contacts The Council To Influence My Housing Rights.
- Tries To Ban Me From My Home Address.
- Interferes In A **Civil Tenancy Matter.**
- And Does So **Without Legal Authority.**

Bail conditions must be:

- Explained.
- Agreed.
- Signed.
- And Lawful.

None of that happens.

#### **6. My belongings and my mother's estate are inside**

I have:

- Legal Correspondence
- My Generator
- My Sound System
- My Pc
- My Rolex
- My Cars
- My Catering Trailers
- My Personal Effects
- My Mother's Belongings
- Estate Items
- Documents
- Sentimental Items

Under the **Torts (Interference with Goods) Act 1977**, I have a **legal right** to access, secure, and protect my property.

### **7. The correct legal position (present tense)**

I am a long-term resident of 23 Byron Terrace, officially recognised by the council as “care-of” at the address. Under the Housing Act 1985, I have a legal right to remain in the property while my succession application is active. The council’s message does not remove my right to live there, access my belongings, or protect my mother’s estate. Police bail cannot override housing law, and the OIC has no authority to interfere in civil tenancy matters or impose conditions banning me from my home without my agreement or a court order.

I have since submitted my right to succession and have a legal right to remain in the property until told otherwise, as **Exhibited Here**:

### **SUMMARY (FOR THE POLICE / CPS)**

I have submitted my Right to Succession and therefore have a **legal right to remain at 23 Byron Terrace** until the Council makes a decision (**Exhibit A1**).

I have also created a diary of the true events leading up to Deon's allegation and the evidence obtained afterwards. The exhibit (**B1**) show:

- 1+ Deon Repeatedly Threatened Me
- 2+ Deon Admitted She Would Force Entry And Call Police
- 3+ Deon's Boyfriend Also Threatened Me
- 4+ I Behaved Calmly And Lawfully
- 5+ I Was The One Being Threatened
- 6+ Deon Had A Clear Motive To Lie
- 7+ The Injury Is On Her **Palm**, Not Her Wrist
- 8+ She Used Both Wrists Normally In Hospital 5 Days Later
- 9+ She Came To Me Aggressively 7 Days Later
- 10+ Family Attempted To Manipulate Serco With False Bail Information!

### **This evidence collectively shows:**

- 1+ I was legally allowed at the property
- 2+ I was the one being threatened
- 3+ Deon was the aggressor
- 4+ The injury is inconsistent with the allegation
- 5+ Deon was not injured in the way she claimed

- 6+ Deon attempted to provoke breaches and weaponise police
- 7+ The allegation is unreliable and should be dropped

**I therefore respectfully request the following:**

1. **That the allegation be reviewed in light of the exhibits provided.**
2. **That the injury evidence be compared with the allegation for accuracy.**
3. **That the OIC review the 13 May incident showing Deon's aggression and mobility.**
4. **That the CPS consider the clear motive to fabricate.**
5. **That the case be discontinued due to lack of credible evidence.**

**P.s.**

I am acting at all times to comply with the original 2018 Edmonton County Court order, which recognised my disability-related need for a two-bedroom property and confirmed that 109 Burncroft Avenue is unsuitable and unsafe for me. Enfield Council failed to comply with that order for seven years, which caused my displacement, the breakdown of my support, and the instability that led to my current bail conditions.

I cannot live at 109 Burncroft Avenue because it is a one-bedroom flat that does not meet my disability needs, the court already agreed it is unsafe, and I have been victimised by neighbours, including a false allegation that now legally prevents me from returning. I have maintained the property in excellent condition and have never abandoned it; I was barred from entering under bail conditions from 02-08-2025 to the present. I wish to return the property to Enfield Council properly, not against my will.

280 Durants Road is not my Secure and Stable home. It is owned by multiple family members who are in conflict, and I experienced interference, removal of my tag box, and restrictions on who I could have around me. I only stayed there because the court approved it as a temporary bail address during my mother's illness. It is not safe or suitable for me.

23 Byron Terrace has always been my true home. I lived there long-term as part of my mother's household, with all my official documents registered there, including my GP, passport, driving licence, and council tax. My belongings, equipment, and care arrangements were based there. Enfield Council themselves treated it as my legal residence. I meet all legal requirements for succession under the Housing Act 1985.

My current bail/tag conditions now prevent me from complying with the 2018 court order, succession law, tenancy law, and my duties to secure my mother's estate. They prevent me from accessing my own tenancy, managing belongings, maintaining identity documents, and stabilising my life after my mother's death. I am requesting lawful variation so that I can comply with all legal obligations, protect my housing rights, and live safely.

My intentions are lawful, protective, and responsible. I want to succeed 23 Byron Terrace, return 109 Burncroft Avenue to Enfield Council in good condition, comply with the court order, comply with succession law, and rebuild my life with the support I now need.

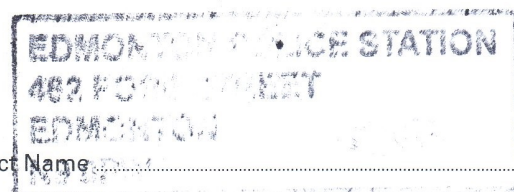

I am writing to confirm that I am bailed to attend the police station on **19/06/2026 at 2:00 PM.**

I also need to make you aware that I will be **resending all evidence, messages, documents, and correspondence** connected to this matter. When I previously tried to submit material through DS Johnston during a period of bereavement, it resulted in delays and confusion, and the files were not added to the case bundle. I want to ensure everything is clear, properly handled, and placed on file this time.

For clarity, I have already submitted:

- **Full case files and evidence bundles**
- **The complete bail variation request**
- **A request for the case to be disposed of (discontinued)**

These will all be resent directly to you, DS Knox, as the Officer in Charge, with DS Johnston copied in for continuity.

I will also include a short note explaining a key evidential point: The complainant claimed I broke her hand in two places, yet the video taken five days later shows her using that same hand normally — no cast, no splint, full movement, and no signs of pain. She bends the wrist across her forehead and takes selfies with it. The hand being operated on in the video is the one she injured in a separate glassing incident, not the hand she accused me of damaging. This directly contradicts the allegation.

**My requests are as follows:**

1. That all evidence I resend is formally added to the case file.
2. That the bail variation request is reviewed and placed on file.
3. That the full evidence bundle is shown to CPS if the case is being reviewed or has already been sent.
4. That CPS are made aware of the contradictions and the request for the case to be discontinued.

### **FOR THE POLICE / CPS**

I have submitted my Right to Succession and therefore have a lawful right to remain at **23 Byron Terrace** until the Council makes a decision (**Exhibit A1**). <Dir> [16. Formal Request to Begin 23 Byron Terrace Tenancy Succession dated 11-05-2026 at time 08\\_59Am](#)

I have also created a diary of the true events leading up to Deon's allegation and the evidence obtained afterwards. The exhibits (**B1**) show: <Dir> [Extra](#)

1. Deon repeatedly threatened me.
2. Deon admitted she would force entry and call police in 23 Byron Terrace even when she had not been staying there!
3. Deon's boyfriend also threatened me.
4. I behaved calmly and lawfully throughout.
5. I was the one being threatened.
6. Deon had a clear motive to lie.
7. The injury shown is on her **palm**, not her wrist.
8. She used **both wrists normally** in hospital five days later with no plaster cast on any.
9. She approached me aggressively seven days later with full mobility.
10. Family attempted to manipulate Serco with false bail information.
11. Deon repeatedly harassed me **after bail**, including calling me while drunk.
12. She contacted **multiple friends** of mine (at least three), leaving threatening audio messages.
13. She sent **doctors to my address** for no legitimate reason, immediately after bail.
14. She **forced herself into 280 Durants Road**, putting me at risk of a bail breach and forcing me to leave and call police to obtain a CAD reference.
15. I logged and exhibited all calls, threats, and messages after arrest.

### **Clarification of the Shouting Incident**

At no point did I spit at Deon.

We were both speaking loudly at the same time, trying to get our points across, and a tiny dot of saliva came out of my mouth **accidentally** — the same way it can happen to anyone when emotions are high and voices are raised.

It was not deliberate, not aimed at her, and not intended as any form of assault.

She was also shouting, and saliva came from her mouth as well.

There was **no intentional spitting** from me at any time.

### **Clarification of the Physical Contact**

The only physical contact was when I **briefly grabbed her arm** to stop her from **smashing up the kitchen further**, after she had already swept knives and items off the counter while shouting she was going to “mash up the rest.”

This was a **split-second protective action** to prevent further damage and danger.

If this caused her any discomfort, I am genuinely sorry — it was **never my intention** to hurt her.

The evidence shows:

1. She continued using the same hand normally.
2. She had **full movement, no cast, no splint, and no pain** in the hospital video.
3. The hand being operated on was from a **previous glassing incident**, not anything involving me.

This directly contradicts the allegation.

### **What the Evidence Shows Overall**

The evidence collectively demonstrates:

1. I was legally allowed at the property.
2. I was the one being threatened.
3. Deon was the aggressor.
4. The injury is inconsistent with the allegation.
5. Deon was not injured in the way she claimed at the time of the alleged incident.
6. Deon attempted to provoke breaches and weaponise police by doing so.
7. Deon harassed me and my friends after bail.
8. Deon involved medical services and attempted to force bail breaches.
9. The allegation is unreliable and should be dropped.

### **REQUESTS**

I respectfully request:

1. That the allegation be reviewed in light of the exhibits provided.
2. That the injury evidence be compared with the allegation for accuracy.
3. That the OIC review the 13 May incident showing Deon’s aggression and mobility.
4. That CPS consider the clear motive to fabricate.
5. That CPS consider the wider pattern of harassment, threats, and attempts to cause bail breaches.
6. **That the case be discontinued due to lack of credible evidence, the contradictions in the injury claim, the pattern of harassment, and the fact that my only physical contact was a brief protective action to prevent further damage, with no intention to cause harm.**

### **Housing & Legal Context**

I am acting at all times to comply with the original **2018 Edmonton County Court order**, which recognised my disability-related need for a two-bedroom property and confirmed that **109 Burncroft Avenue is unsafe and unsuitable** for me. Enfield Council failed to

comply with that order for seven years, causing displacement, instability, and the circumstances that led to my current bail conditions.

I cannot live at 109 Burncroft Avenue due to:

1. Disability Needs
2. Previous Victimisation
3. A False Allegation Preventing My Return

I have maintained the property in excellent condition and have never abandoned it; I was barred from entering under bail conditions from 02/08/2025 to the present.

**280 Durants Road** is not a secure or stable home. It is owned by multiple family members in conflict, and I experienced interference, removal of my tag box, and restrictions on who I could have around me. I only stayed there because the court approved it as a temporary bail address during my mother's illness.

**23 Byron Terrace** has always been my true home.

I lived there long-term as part of my mother's household, with all my official documents registered there. I meet all legal requirements for succession under the Housing Act 1985.

My current bail/tag conditions now prevent me from complying with:

1. The 2018 Court Order
2. Succession Law
3. Tenancy Law
4. My Duties To Secure My Mother's Estate

I am requesting lawful variation so that I can comply with all legal obligations, protect my housing rights, and live safely.

My intentions are lawful, protective, and responsible.

I want to succeed 23 Byron Terrace, return 109 Burncroft Avenue to Enfield Council in good condition, comply with the court order, comply with succession law, and rebuild my life with the support I now need.

#### Police Bail Was Never Lawfully Imposed — Corrected Timeline & Breaches

I am innocent from the offset in these proceedings.

I therefore set out the factual sequence of events regarding my police bail. These facts show that the conditions were **never lawfully imposed**, and that multiple breaches of PACE and custody procedure occurred.

##### 1. I refused to sign the conditions and legally requested to be taken before a court

When the custody officer attempted to impose the bail conditions, I **refused to sign** because I believed the conditions were unlawful and breached my rights. I also **requested to be taken before a court** if the police insisted on imposing them.

Under **PACE Code C**, when a detainee refuses to sign bail conditions:

- 1+ the refusal MUST be recorded in the custody record
- 2+ the MG4A MUST be marked “refused to sign”
- 3+ a witness MUST sign
- 4+ the detainee MUST be given a copy BEFORE release
- 5+ AND the custody officer MUST carry out a review and either:
  - **Remove The Conditions, OR**
  - **Remand The Detainee To Court The Next Morning**

These steps are **mandatory**.

They are not optional.

##### 2. The police illegally ejected me instead of following the legal process

Instead of carrying out the required review, the police:

- 1+ Forcefully Ejected Me From The Custody Suite
- 2+ Without Recording My Refusal
- 3+ Without Marking The Mg4a
- 4+ Without A Witness Signature
- 5+ Without Serving The Bail Form
- 6+ Without Giving Me Any Paperwork
- 7+ Without Removing The Conditions
- 8+ Without Remanding Me To Court
- 9+ Without Completing The Lawful Bail Process

This is a **direct breach of PACE Code C**, because the police chose an option that **does not exist in law**.

Under PACE:

- 1+ If a detainee refuses to sign, the police CANNOT legally release them until a review is completed.
- 2+ The police MUST either remove the conditions or remand the detainee to court.

3+ Ejecting the detainee is unlawful.

Because none of the required steps were followed, and because I was released without any lawful decision being made:

**None of this happened.**

Instead, I was **ejected from the police station** without being given any paperwork, meaning the police bail conditions were NOT legally in effect at the moment I was released.

This is a **serious breach** of PACE and custody procedure.

I later found the first bail sheet in my paperwork — dated 16 May 2026

The first MG4A bail sheet I ever saw was discovered in my paperwork on **16 May 2026, eight days after the alleged offence** (8 May 2026 at 10:00).

This proves:

1+ I Was Never Served The Bail Sheet

2+ I Was Never Given A Copy

3+ I Was Never Shown The Conditions

4+ I Was Never Given The Opportunity To Sign

5+ The Police Released Me Without Lawful Service

This is a **fatal procedural failure**.

### **3. The OIC contacted me on 9 May 2026 at 22:35 — more than 12 hours after release**

The OIC messaged me:

*“Please let me know email and I will send you an updated copy of the bail sheet.”*

This message was sent **over 12 hours after my release**, which is extremely serious because:

1+ Bail Conditions Must Be Imposed **Before Release**,

2+ They Cannot Be “Updated” Afterwards.

3+ They Cannot Be “Re-Issued” Once The Detainee Has Left Custody”

4+ And The Police Have No Power To Impose Or Amend Bail Remotely.

This alone makes the bail conditions **unlawful and void**.

### **4. Met CCC confirmed NO bail conditions existed for two days**

Between **9–11 May**, I contacted Met CCC multiple times.

Their CAD messages confirm:

1+ They Could Not Find Any Bail Conditions,

2+ They Had To Contact The OIC To Ask Him To Explain Them,

3+ The Cad Was Still Open,

4+ And No Conditions Were Visible On The System.

### **This Means:**

I was released with no active bail conditions for at least 48 hours.

This is a catastrophic breach of PACE.

### **5. The OIC admitted the custody record was still open — which is why no conditions existed**

When I phoned the OIC, he told me:

1+ The Custody Record Was Still Open,

2+ Shift Changes Had Occurred,

- 3+ No One Had Closed The Cad,
- 4+ And This Is Why No Conditions Were Updated.

This is a breach of:

- 1+ PACE
- 2+ Custody continuity
- 3+ Data handling
- 4+ Professional Standards
- 5+ Article 6 (fair process)

## **6. On 14 May 2026, I received a second bail sheet — falsely marked “Refused to sign”**

The second bail sheet was:

- 1+ Created AFTER Release,
- 2+ Sent To The Wrong Address (280 Durants Road),
- 3+ Falsely Marked “Not Digitally Signed – Refused To Sign,”
- 4+ Created Without Me Being Present,
- 5+ Created Without Caution,
- 6+ Created Without Service,
- 7+ And Created Without Lawful Authority.

This is extremely serious because:

- The police fabricated a refusal that never happened.
- They created a bail document after release, which is unlawful.
- They attempted to retroactively impose conditions.

This breaches:

- 1+ PACE
- 2+ CPIA
- 3+ Custody record integrity
- 4+ Professional Standards
- 5+ Article 6 ECHR
- 6+ Data Protection Act 2018
- 7+ UK GDPR

## **7. Legal conclusion**

Based on the above:

- 1+ My bail conditions were never lawfully imposed
- 2+ The MG4A was invalid
- 3+ The re-issued bail sheet was unlawful
- 4+ I cannot be in breach of conditions that were never served
- 5+ The police process was procedurally defective
- 6+ My Article 6 rights were violated
- 7+ The custody process was mishandled
- 8+ The CAD was left open across shifts
- 9+ No Superintendent extension was obtained
- 10+ The police attempted to impose bail after release

This requires urgent review.

### **13.2. Doc2 What Happened With Deon**

#### **Bailed to Wood Green Police Station**

**Station address:** 347 High Road, Wood Green London, N22 8JA.

**Bailed to date/time:** 19/06/2026 14:00

When I first entered my home 23 Byron Terrace, I noticed around eight black bags in the front room, tied up and ready to be thrown away. I looked inside them and saw they contained my mum's old clothing. I believed my uncle had bagged them up while sorting the property, as he was waiting for a new front door to be fitted. I moved the bags upstairs into my mum's room because I knew I would need to check them properly to see if they were rubbish or if any of my savings had been placed in the bags.

I was staying indoors at **23 Byron Terrace**. Earlier, I had picked up my mate **Josh** for support. He had agreed to help me and stay at **109 Burncroft Avenue** while the front door was being changed due to the damage caused by the police on **02/08/2025**. This took about five hours, so after dropping Josh off, I went back to 23 Byron Terrace to sort the door situation and continue working in the house.

While I was inside alone, my aunt arrived at the door. I told her I wasn't happy with her. She asked for a Hoover that belonged to her and was still in the house. I either got it for her or handed it to her. Later, I saw a red car arrive again, and thinking it was her returning, I shouted for them to leave me alone. I didn't trust her anymore because she had been involved in withholding my money, refusing to give me the keys, and getting me arrested with my cousin. I later found out it was actually my younger cousin and not my aunt. As much as I loved her, I still wouldn't have let her in because I was looking for my money and sorting out mine and my mum's belongings after they had all been tampered with.

After that, I picked Josh up again and we both went back to 23 Byron Terrace. We continued working in the garden and garage until we had some food and then went to sleep on the two sofas in the front room. At no point did I allow anyone else into the home while I was searching for my money. I left the upstairs alone because we needed the space and storage from the garage first, as the attic and two rooms were filled with personal effects.

When we woke up the next day, we continued working in the garage and jet-washed the garden. Afterwards, I needed to drop Josh home because he had an appointment, so I did that. Later, I found out that while Josh was at mine, my sister believed he was supporting me and sent him threats on his phone, which I have exhibited along with other recordings and transcripts.

My mother had long-standing issues with the upstairs bathroom and couldn't get a shower fitted. I phoned a friend who is a plumber and asked if he could help. He attended the property and said he could revamp it cheaply using leftover parts from previous private jobs. I agreed, and I helped him complete the new works. My sister must have seen him on the doorbell camera and phoned him with threats as well, for no fair reason.

This was confusing because before she left for holiday, I had been helping her with her housing issues — she had called me the day before and explained them to me. I had also helped her with her Firestick, as shown in the video exhibited below. She had no reason to argue with me or believe anything bad.

A few days later, I started receiving threatening phone calls from my sister's boyfriend. I told him I didn't understand why he was phoning me out of the blue accusing me of things. He kept

threatening me and wouldn't listen or make any sense. I also started receiving silent messages from my sister. I didn't take them seriously at first, but I was still concerned.

I contacted my father and told him I was going to go through the house paperwork and make sure all his and everyone's personal effects would be given to them by me. I sat down and went through everything systematically. I told my father I had found items of importance to him and that I would bring them to him. He was fine with this. I was alone at these times.

Later, my friend **Perry** called me saying he had an argument with his partner, so I told him to come and stay with me for the night. We ordered pizza and fell asleep separately on the two sofas.

The next day, while I was in the kitchen cleaning and Perry was sitting in the front room, my sister arrived. **Tyrone** arrived first and started accusing me of giving things away. I told him he was wrong. He was looking for a set of Ugg boots he had bought for my mum. I told him I wasn't in the wrong — the deal was that we all wait for each other: me, Deon, and Tyrone. Instead, he had gone into the house with my sister on the same day my cousin and aunt had set me up for entering 23 Byron Terrace, and they had split everything, including the gold, unfairly. Now all he could remember was a pair of Ugg boots, and he was using that to argue with me. I asked him who told him I had given mum's Uggs away and that they had seen Katie wearing them. He said it was Deon. I told him he was mad. He offered £500 if I found them. I went and found them exactly where I told him they were, where he had already looked earlier when he stormed in. He took the gaming router and left.

The next day, **Deon** returned from holiday. She was spiteful and manipulative, with no morals or dignity. She sat down on the sofa and started shouting at me, accusing me of burning all of mum's stuff. I told her she was wrong, just like Tyrone had been the day before. She didn't listen, and we both started shouting. I was defending myself from her horrible accusations. As we were shouting, a small dot of saliva came out of my mouth and touched her by mistake. She went mad, and as she shouted, some of her saliva hit my face. I shouted, "See how easy a mistake it is," and she stormed into the kitchen.

I followed her, and as I turned into the kitchen, I saw her use the same hand she now claims is broken to smash everything off the side — all the kitchen utilities, including sharp knives, went onto the floor and the worktop. She shouted, "I'm going to smash the whole house up." I had just been in the kitchen four minutes earlier tidying up. Me and my close friends, who knew my mother well, had been quiet and respectful the whole time. For her to turn up and do this made no sense.

I grabbed her arm as she went to use it again and stopped her, but she twisted and turned. I noticed she was trying to pull her top off, which would have exposed her in front of me and my mate, so I immediately let go in the hope she would calm down and not try to use the knives or smash anything else. She then stormed into the back garden and shouted that she had seen us burning stuff on the camera. I then understood what she meant and shouted back, "You idiot, you're on about the old rags uncle threw out in the black bags."

I saw that my sister was in the back garden, so I locked the back door for safety and quickly picked up the knives that were on the floor and on the kitchen side. I put them away immediately. While I was doing this, she started hitting the back door. I finished within seconds, went to the door, told her to calm down, and opened it. She didn't come back inside but instead called the police, who arrived and wrongly arrested me for common assault.

At the police station, I was also wrongly detained for an alleged tag breach. This was because I had checked my front door when my house alarm went off. I had contacted Met CCC at the time

and was given permission to check the security of the flat. The OIC checked the CAD, confirmed this, and the tag-related allegation was dropped.

While I was in the cell, I gave the OIC the code to my mobile phone so they could check the threats made to me by my younger sister, Deon. The phone was brought to the cell flap still sealed in a property bag. I remembered that when I was booked in a few days earlier, I had joked with the same officer about my phone being damaged — the screen had been cracked on that occasion. I told him the phone was basically new because I had just had the screen repaired, although I hadn't replaced the back cover as I didn't buy that part from eBay. He laughed and agreed it looked almost new. I hadn't seen the screen working before this moment. The OIC showed me the phone through the property bag as they searched it for the threats made by Deon and her boyfriend. The screen was working at that point.

During the interview, I was shown a picture of my sister's wrist. The interviewing officer said, "It's just a graze," and I replied, "Exactly — it's just a graze. If I had grabbed her and hurt her unnecessarily, it would be more than that." I explained that she caused it herself when she swiped the knives and kitchen utilities off the side. The officer accused me of deliberately spitting at my sister, grabbing her, and causing the items to fall. She also claimed I forcefully removed my sister into the back garden. I took these accusations seriously and told her the real events. I told them to check their Axon body-worn cameras and to note that my mate Perry was present and would give a statement confirming my account.

Later, I was taken out of my cell to be bailed by the OIC. As we walked into the custody room, I was partly told that I couldn't attend 23 Byron Terrace. As soon as we reached the custody desk, I told the sergeant in charge that I would not accept any bail conditions restricting me from my home address. I said that if he believed such conditions were necessary and refused to change them, I would rather go to court in the morning. I explained that banning me from my home breached my human rights, especially considering my bereavement, the fact my sister was not registered at the address, and that I was officially "care of" 23 Byron Terrace. All my personal correspondence was still registered there, and I had always lived there due to the support I needed as ordered by the court and doctors.

He said he understood that I was refusing to sign and that he was not sending me to court. He then said that if I didn't leave Wood Green Police Station voluntarily, he would have me forcefully removed. Around five officers surrounded me. I said I would leave and walked out without hearing the bail conditions or agreeing to them. A piece of paper with support numbers was placed in my belongings. I was never given a bail sheet, but I was given back my phone with a cracked screen.

The two officers who took me out the cell I believed the male to be OIC in the case as outside gave me his number while outside of the police station and said he would contact the council to see if I was allowed to stay at the property. I told him all my belongings were there — my generator, sound system, legal correspondence, cars on the driveway, catering trailers, PC, Rolex, and more. I told him it was unfair and that he had no legal right to involve himself in civil matters and asked him not to contact them, but he would not change his mind, he told me before I left that I can changed the bail conditions he imposed with other officer by contacting them at the police station and the details for this are on the bail forms.

I went back to **280 Durants Road** and contacted Met CCC to ask about the bail conditions, but they couldn't find any record of them. They messaged the OIC,

1+ 9 May 2026 at 11:40:02

2+ 9 May 2026 at 16:27:57.

I remember the OIC had put his number in my phone, so I called him on **09 May 2026**. He went downstairs and realised my CAD had never been closed and that I had refused to sign and been released. He said he would close it and update the conditions. I became upset and explained my legal points. He told me I would need to write to them to vary the bail conditions. I told him my sister partly owns my nan's house as well, but they can't ban me from there — and the same applies to my mum's house. If anything, they should bar me from her registered tenancy address, not mine. He didn't care.

Next, my sister and brother called the police to my nan's house for no reason, trying to get me sectioned.

After this, the OIC in Deon's case still placed bail conditions on me **even though I refused to sign them**. He then contacted the council about my right to be at 23 Byron Terrace. As a result, Met CCC sent me the following message on **Sunday 17th May 2026 at 10:18**, confirming the council's position:

**From Met CCC**

Sunday 17<sup>th</sup> May 2026 at 10:18

Dear Simon, we have received the following notification from the council concerning your Tenancy Status...

Based on our current records, please see the factual position below:

The legal tenant of 23 Byron Terrace was Simon's late mother, Miss Lorraine Cordell who reportedly passed away on 07 April 2026. We have not yet received the death certificate.

At present, there is no current legal tenant recorded on our system for the property.

Mr Simon Cordell is not named on the tenancy and is not currently a lawful tenant of the property.

Mr Cordell has advised the Council that he is in the process of completing a succession application, which has been issued to him.

Until a succession application is submitted, assessed, and approved, Mr Cordell has no confirmed legal right of occupation under the tenancy.

This is the current status as held by Enfield Council Housing. Please let me know if you require any further information.

**My Legal Right to Be at 23 Byron Terrace (Present-Tense Version)**

The council's message is technically correct, but it is **not the full legal position**, and it does **not** mean I cannot legally live at 23 Byron Terrace or sort out my personal effects.

**1. Children of secure tenants are not added to the tenancy — but they still have legal rights**

Under the **Housing Act 1985**, Schedule 3:

- Councils **Do Not Add Children** To Secure Tenancies.
- This Is Standard Policy Across The UK.
- Not Being Named On The Tenancy **Does Not Remove My Right To Live There.**
- Not Being Named On The Tenancy **Does Not Remove My Right To Remain After My Mother Dies.**
- Not Being Named On The Tenancy **Does Not Remove My Right To Apply For Succession.**

Me, my brother, and my sister grow up in that home.  
We live there legally as part of the household.  
That right **continues** until succession is decided.

## **2. I am officially “care-of” at 23 Byron Terrace**

### CHAPTER 1 — 2nd August 2025: The Arrest, the Ambulance, and the First Betrayal

The day everything started to unravel was 02/08/2025 when I was arrested and excluded from 109 Burncroft Avenue and had to leave the alarm on!

The police abused their powers against me on this day.

My Auntie Sheila was present as well as other members of my neighbors who were also present and she as my aunty to me has always been the woman other than my mother I next trusted the most as she is the woman who raised me like a second mum.

While my mother was ill on the 02/08/25 I asked my aunty to take her place and act as my **appropriate adult** at the police station instead.

At that moment, I still believed she was on my side but since then a few things have happened that have made me think shall I change my mind?

I know she cares and loves me but now I am in doubt a little as to what extent, as her recent actions have shown a despite to our relationship.

I still believed she would protect me as she had promised to herself me and our family in my times of need and I knew that I would protect her till the ends of our life's by both of us sticking together in times of hardship as good family's do by doing the right things by one and other and for all the family members and not just ourselves! But I have since learned life is not always so simple, as planned or visioned.

The truth be is that after my recent hard times I had lost a lot of money in a community business adventure I played a major role in, so I had been saving a small amount of my money from my benefits each week so that in my times of need I could provide and this also meant that I had brought items, thing that I needed, as I was provided the money and latter sell a few of those bits to acquire the higher sums for more expensive products.

I had been saving and acquiring legal funds by release assists I no longer required as much as I could so I could by a summer house for my back garden that I could use as an officer for my hobbies and official correspondence so I could have space for a family within my home itself to raise a sibling of my own.

To save the Money I had asked my mother to make contact with the eBay sellers so the products I wanted could be ordered and fitted as installed by them, I wanted a summers house and jacuzzi, as well as a home fit for a king and queen. so, I had to account for the correct value for these items which was both of a high value. I had also used Klarna to pay monthly installments for the foundation in the back garden and asked for friends help to help keep the cost down. I had allowed the work to start late summer due to available money but we still all managed to pull together and complete the back garden ready for the best install dates for summer 2026. My Mother was in comunicado with both sellers as they needed time in advance, and I had hoped to rush things for the year earlier.

## **02/08/2025**

An alleged incident that I did not commit was reported against me to the police by a next-door neighbor the police arrived and I was then afterwards taken to the hospital. But before I was taken

Away I was brought outside of my property and sat on the floor awaiting the Ambulance and at this stage my Aunty was present with me, so I told her where my money was and asked her to secure it by giving it to my mother.

I trusted her.

She went inside, took the money, and gave it to my mum what was my sum of money equaling to 7k under the freezer at **109 Burncroft Avenue** — money I had saved honestly, slowly, painfully, from saved mostly from my benefits, from being indoors on curfew, from trying to build a future without crime and that I had keep separate from the money I had given to my mother as it was saved so I could do the internal renovations in the flat while I waited for the new summer to approach.

At the time, I thought nothing of it after than it was safely put away till needed.

She was helping me in my time of need as my door had been made insecure and I was being taken away from my premises and all while police and locksmiths were still inside!

I know she gave the money to my mother, but my question is did she take it away again afterwards by taking advantage of me and my mother?

## **CHAPTER 2 — 4th August 2025: The Tag and My Mum's Last Act of Protection**

On **04/08/2025**, the court placed me on an electronic tag and assigned me to my sister's address.

But when I got there, it wasn't feasible for us all, as she was living in another flat while her own was being rennervated or swapped for a new tenancy home.

My mum realised this and set a new ruling due to the temporary flats condition not being of the best of states and as we noticed this impossibility of living we all remembered her own medical needs and that meaning that my bedroom at 23 Byron Terrace was being used to support her medical condition at that time in present so I could not use it as I normally would!

She knew the normal layout and that would be that I would naturally be staying with her, but her illness prevented it.

She knew what was realistic for the family.

So, she wrote to the court — from her iPhone — requesting an urgent hearing on **08/08/2025** to change my bail address to **280 Durants Road**, the house she shared with her brother and sister.

The court agreed to this request of hers.

This was the last major protective act my mum made for me before she passed away on **07/04/2026**.

She never revoked it.

She never changed it.

She never wrote anything different.

She wanted me safe.

She wanted me stable.

She wanted me home and to live how it would be normally be for us before she got ill, but none of us could make this happen life had took it out of all of our control.

I was not to relies on this date but latter that all this would be down to the police officer in the case “*PC Quick for charging me without further arrested for the new Criminal offence he charged me with and without any lawful legal process as I was denied everything legal once he became the OIC in the case for the new offence.*”

Pc Quick is noted in the polices and CPS Disclosed materials as the new OIC without any lawful further arrest and ;legal process.

#### **Police Irregularity: Officer in the Case (OIC) – PC Quick**

The custody record for 04/08/2025 identifies **PC 01 P257543 Quick** as the *Officer in the Case* for the substituted charge of “Threats to Damage/Destroy Property”, recorded at 03:09.

However, at no stage has **any officer named PC Quick ever been met, contacted, or identified** by myself, my Appropriate Adult, custody staff, or any solicitor. No interview was conducted by him, no arrest was carried out by him, and no investigative actions are attributed to him.

I later discovered that a Metropolitan Police officer named **PC Nathaniel Quick** exists publicly through a misconduct hearing notice. The surname and role match the name recorded in my custody record, but **no warrant number, station, or confirmation has ever been provided** to verify that this is the same individual.

This creates a **procedural anomaly**: the OIC responsible for the substituted charge is a person who has never been present, never engaged with the case, and cannot be verified. The substituted charge was therefore created **without a lawful investigative officer**, without interview, without arrest, and without the required MG4/MG5 documentation.

This irregularity undermines the lawfulness of the charge, the integrity of the investigation, and the ability to prepare a defence. It forms part of the cumulative procedural unfairness requiring an Abuse of Process hearing.

### **CHAPTER 4 — The Family Dynamics They Pretend Don't Exist**

My dad lived at **280 as a guest**, not a tenant.

He never paid rent, aloe he paid his way!

We as a family supported him as we must when he needed us the most as life brought him to a place that made him feel like He had nowhere else to go!

My uncle Andrew hadn't lived in my nans from a young age of about 16 years old, but he reappeared as a permanent fixture after my nan his mother sadly passed away for us all as a family.

He walked away long ago and since his arrival he has been open and honest that his intentions are to sell his mother and father's home my nans house to us grandchildren who have resumed in the home growing up while he has been away more than majority of the time.

Due to his long-term absinth, both of his sisters had a lot to catch up with him about life this was also Viser verse, and his arrival meant to us as a family that we would obviously never want him to disappear again like he had before and all as we were growing up.

As my mother became ill, he became her backbone, supporting her in ways she would never allow her sons to assist her with.

My Auntie Sheila was always present and supportive, exactly as I would have expected. She has always been there for me and for all of us, every day when needed, since we were born. She has spent most of her life living in Lower Edmonton, not at 280 Durants Road in Enfield, and for as long as I can remember she had already moved out of Nan's house before I was even born.

She pays her own council tax at her own address, and after the inheritance she continued to maintain the council tax bill at 280 as well.

She openly admits in her text messages that she does not live at 280, and that I have been the one living there.

### **Yet both of them my Aunty and Uncle:**

- Tried To Control Me
- Tried To Use My Tag Against Me
- Tried To Push Me Out Of My Home's
- Tried To Interfere With My Legal Inheritance

My mum didn't want them as next of kin.

She only agreed after checking the law and realising they couldn't take her house or inheritance rights Away from us her siblings.

### **CHAPTER 5 — The Money: Years of Saving, Now at Risk**

I saved money for years —

from my benefits, from being indoors on curfew, from trying to build a future.

I gave my mum money to keep safe.

She kept it in her bedroom.

After her death, my aunt and uncle had access to her bedroom and the complete house but mostly my uncle. I didn't.

Also, Uncle stated he knew nothing of any savings of mine being kept safely by my mother. But I am deeply concerned.

My aunt and uncle:

- lied
- manipulated
- blackmailed
- tried to use the criminal court
- tried to get me arrested
- tried to push me out of my home
- tried to interfere with my inheritance
- tried to sabotage my defence

My uncle even tried to shake my hand and say:

**“It’s on between me and you.**

**We’re getting you out of 280.”**

I refused.

This is not a game.

This is my life.

My home.

My mum’s wishes.

My future.

And I will not be persecuted for telling the truth.

My House alarm went off at 109 Burncroft Avenue, and this caused me to immediately contact Met CCC 999 and report the possibility of a house intruder, and this caused me to jump into my car and head straight to a street close to the property where I could not be arrested. I spoke to the police assistant on the phone, and they stated it will be a while till they arrive, I therefore asked if I could be granted the permission to run up to the front door and make sure the police padlocks they had put on the door when they booted it of was still secure, he stated he would need to ask and soon came back with a reply of yes as long as I stay on the phone. I run to the door a saw the locks still present and confirmed this with the police officers and run straight back to my car and drove off. No one to help, I was left without any person who could help me confirm the rest to be an electric fault. The cad for this day is as below!

The police refused this request, and it left me in a state of trouble. Luckily for me one of my friends who still lives local named as Kaite saved me as she allowed for me to pick her up and bypass the Tag Exclusion restriction when I had no other person to help me!

I picked her up and she went in and confirmed the flat to be safe and turned the electric back on for me. While we were driving back I received a telephone call of Enfield Council stating they wanted to install the new front door in that should have been completed back in January 2025 with the rest, but I was prolonged by them. I would also like to mention that since the door was damaged by police the Enfield Council has refused all my requests to install the new type door or fix the old type. The Lady on the phone said she wanted to book a new install date for the new type door and when checking her calendar, she stated she had a slot free for the next day dated the 30<sup>th</sup> April 2026, I knew I would need help and looked at Katie in the passenger seat and told her everything and then asked her if she could help me sort it all out by waiting with them while they changed the door, she agreed and the appointment was booked. I told her I had the set of keys to my mothers and what had been going on and that I need to check and look for it, would she come with me as I've not been allowed in since my mother death, she agreed.



We went to my home My Family home 23 Byron Terrace and I let us in and no one we there I took caution and only allowed access to the kitchen while I checked it, then I systematically checked the bathroom and front room so I could release access to them and be sure that my saved money was not in those room or anything of value that could cause any unwanted issues of concern. Kaite's sons came around after and we ordered food and ate, she then went home with them, and I stayed in the house.

Later that night I took a drive to see Katie to make sure all was good for the next day as her phone was damaged, she had met her friend and started to have a good night so I knew that this would interfere with the fixture of my new front door and ended up picking up another mate of mine, Josh who lives miles away late in the nighttime and then we both went back to my mothers. I knew downstairs was not where the money was stored as I had earlier checked and I also knew that's my uncle & Co all sleep most of the time downstairs in the front room while supporting my mother so it would be very unlikely that she would hide it with them.

But then came the banging at the front door of 280 Durants Road and on checking who it was it became apparent that it was no one other than my sister and brother. The Ambulance drivers analyzed there behaviour and spoke aloud first, by stating: " Were not going out their shall we call the police," I said Deon should not be here this is unfair, she done 23 Byron by stopping me go there now she's doing here as well! I asked momentarily if they call the police will I b getting detained under Mental Health or for criminal Activities or a breach of the peace" they both replied at the same time no and I agreed it's the best thing to do then. As they were on the phone to the police asking for a dispatch fast response I heard a key go into the lock and my Aunty Shelia then started to open the door to let my sister in to get me with my brother as she stating you cant stop us from coming in, I said aloud "this is unfair Deon got me barred from going to my own home 23 Byron Terrance now she's coming her and I'm not allowed to make contact indirectly or directly and your putting me in breach of this!" she shouted I don't care and they all barged not 280 Durants road, I went out the door with my bag and key and jumped into the car and said to the Ambulance drives I will call you all in an Hour or so, she asked if I will be alright and I replied yes to her as I put the key into the ignition and started the car to then drive of down into the street, while minding the speed limit and any oncoming police cars.

I called 999 about 20 minutes later and got to speak to a gentleman and he help me further with a police Cad instead to report what had happened. He asked me to attend the police station to do the reports, and I said I will speak with my solicitor first.

I drove back to 280 Durants road and thought I noticed my brother changing the locks as he had his tools out and hurried in, but I was soon to find out they were installing cameras so they could watch me inside and out of the property and most importantly that my sister was not present with them!

I went to my bedroom and collected some cash and other objects I would need if I had to get away again and noticed my tag box was missing. I knew that Serco tagging was attending my address as they were dropping a new charger of to me as for what Deon had Deone to me while at 23 Byron Terrace meant I left the charger there and could not collect it.

I left the property and drove up the road again and called Serco Tagging first: they stated Aunt had met the tagging person and signed a waver stating I am not allowed to live in 280 any longer and that she is the owner.. she also stated to them that this was now a police condition bail that I be excluded from 280 Durants Rd as well, I told the operator that this was all a lie and her wrong doings, but he said it could not be changed now unless the police contact them back and agree that there is no police bail preventing me from residing at the address of 280. The Serco adviser gave me his name and ID to the call and advised me to call the police and get them to contact them back or no reinstall.

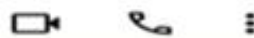

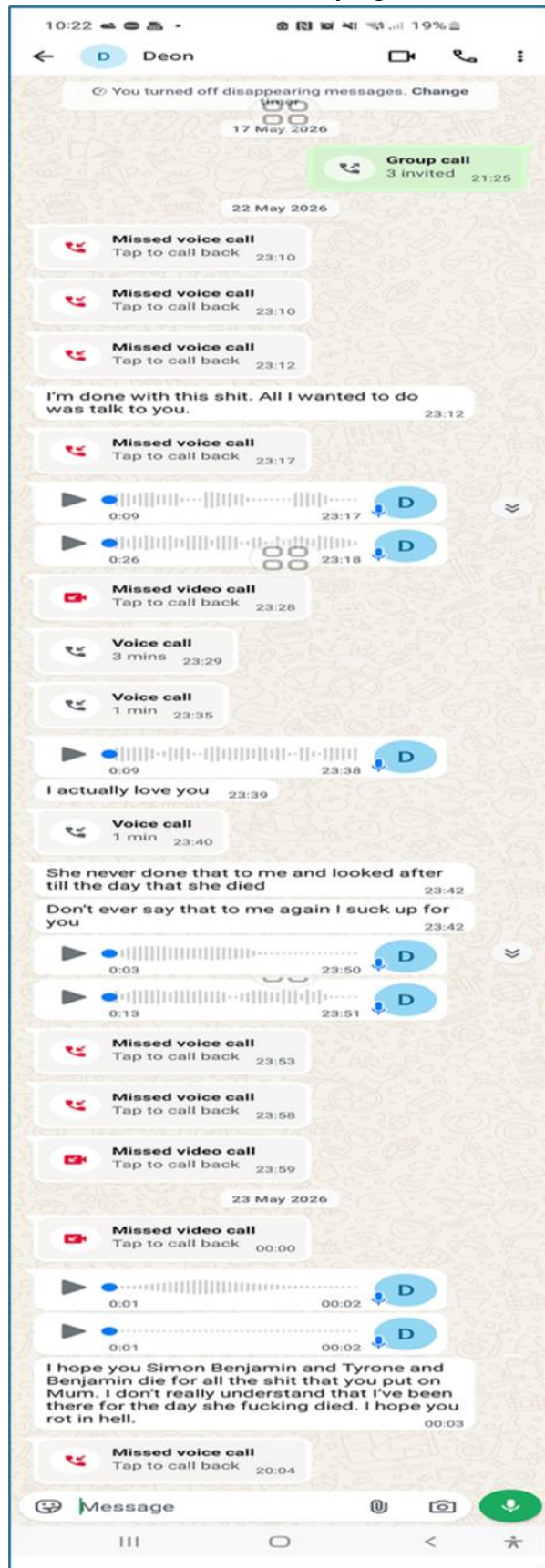

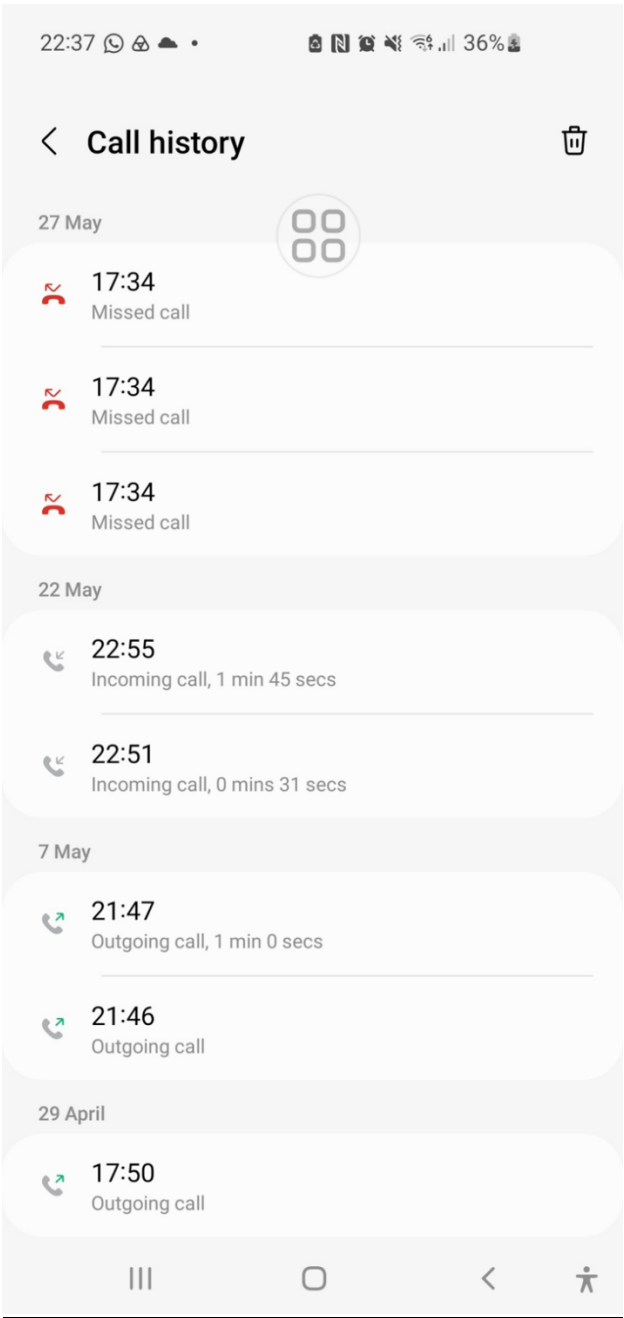

- **A request for the case to be disposed of (discontinued)**
