Thank you for your assistance so far. I just wanted to clarify my request, as Camden Registrars have explained the issue clearly to me.

Camden Registrars cannot currently see my mother's interim certificate on their registration system. They have advised me that they are unable to book the death registration appointment until the coroner updates the case and releases the interim certificate information into the system.

I am therefore requesting that your office updates the case and sends or authorises the interim certificate details so that Camden Registrars can proceed with the registration.

You will not be able to obtain a full death certificate until we close our investigation or open an inquest, and the Coroner will not make that decision until all tissue samples have been examined and a full post-mortem report is received. This can take up to 12 weeks. An interim certificate will allow you to deal with your Mum's affairs.

I will contact you when the post mortem report has been received.

Hello, I hope you are all keeping well, and I would first like to thank you for your assistance so far.

I've been advised that it is best to register my mum's death in Camden, as this is where she passed away at the Royal Free Hospital. When I spoke with Camden Registrars, they explained that her details have not yet been added to the system, and that I should contact your office to request that the coroner updates the case so the registration can go ahead.

It has been explained to me that I cannot currently proceed with booking a registration for my mother, or for my family and myself to obtain the full death certificate, until the coroner's information is entered into the registration system.

Could you please update the record, or let me know if you need anything further from me to complete this. I would also be most grateful if you could contact me back by email with an update regarding this request.
