I have previously contacted your office on **22 July 2026** and again on **12 August 2026** requesting confirmation that the Warning was received, sealed and recorded.

On **13 August 2026**, I was informed that your office was experiencing delays and was processing warnings received on or before **9 June 2026**.

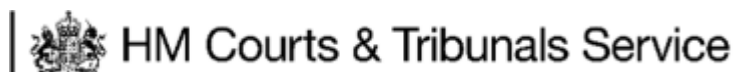

Good morning, Leeds Probate Team.

I am writing to request an urgent update regarding the Warning I submitted. The Warning was sent by Royal Mail Special Delivery Guaranteed under tracking number **AS598862828GB** and delivered on **10/07/2026**. However, it has now come to my attention that the Warning was delivered to the “**Visit Us**” address for Leeds District Probate Registry:

York House 31 York Place Leeds LS1 2ED

This postcode (**LS1 2ED**) is **not** the correct processing centre for caveats and warnings. The correct postal section on your official page is listed under “**Write to Us**”, which shows:

York House 31 York Place Leeds LS1 2BA

Because the Warning was delivered to **LS1 2ED** instead of **LS1 2BA**, it appears it may not have reached the correct internal department responsible for processing caveats and warnings.

As a result, twelve days have passed since delivery, and I have still not received confirmation of receipt nor the sealed Warning.

For clarity, I attach below the **Warning letter** I issued, along with the **previous covering letter** that accompanied it:

"I am the eldest of the three biological children of the deceased, Lorraine Caroline Cordell, and therefore hold statutory priority to apply for the grant of representation under the intestacy rules. As a child of the deceased, I am entitled to administer the estate, and no person has superior entitlement.

The caveator, Tyrone Benjamin, is also a biological child of the deceased and therefore of equal degree, but he does not have priority over me. No lawful grounds have been provided to justify the entry of the caveat, and no dispute has been raised regarding the identity of the deceased, the validity of the death, or the intestacy position.

I therefore require the caveator to enter an appearance within 14 days, setting out the legal basis on which he seeks to oppose or delay the grant. If no appearance is entered, I will apply for the caveat to be removed."

Dear Registrar,

Please find enclosed my completed Warning relating to the caveat entered against the estate of my late mother, Lorraine Caroline Cordell.

I am the eldest of the three biological children of the deceased, and under the intestacy rules I hold statutory priority to apply for the grant of representation. I submitted the original application for the grant, which has now been stopped due to the caveat entered by Tyrone Benjamin, who is also a biological child of the deceased.

The caveator has provided no lawful grounds for entering the caveat, and no dispute has been raised regarding:

- 1) The Identity of The Deceased,
- 2) The Validity of the Death,

- 3) The Intestacy Position, Or
- 4) The Entitlement to Apply for The Grant.

I therefore request that the enclosed Warning be sealed and returned to me so that I may serve it on the caveator in accordance with the Probate Rules.

Once served, the caveator will have 14 days to enter an appearance. If no appearance is entered, I will apply for the caveat to be removed so that the grant of representation may proceed.

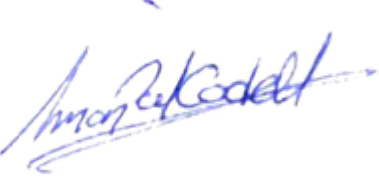
